

## **Highlights from October 2013**

- In October, 26 new ETPs listed on NYSE Arca
- At the end of October, 1,416 ETPs were listed on NYSE Arca
- US ETP notional volume represented 27.19% of all CTA issues in October 2013. This is up from 25.97% from October 2012
- US ETP daily average turnover was approximately \$64.6 billion in October 2013, up 30.34% from \$48.30 billion in October 2012
- NYSE Arca was at the NBBO 90.41% of the time, leading all US exchanges
- NYSE Arca had 21.3% of all US ETP trading volume, leading all US exchanges






#### **U.S. ETP CONSOLIDATED VOLUMES**

- By the end of October, US ETP share and notional volume represented 16.16% and 27.19%, respectively of all CTA issues
